### Data Protection

We will take all reasonable steps (including appropriate technical and organisational security measures) to protect your personal data. All vehicles that use the M8 Rathcormac/Fermoy Bypass are photographed / video recorded. These photographs / images are retained for the purpose of enforcement and to address and resolve any disputes that may arise in relation to a vehicle or a Direct Route exemption card. We may disclose your personal data to our agents, contractors and service providers to the extent reasonably required for the purposes described above. If at any time we decide to use your personal data in a manner significantly different from that stated in this data protection notice, or otherwise disclosed to you at the time it was collected, we will notify you, and you will have the choice as to whether or not we use your information in the new manner. You have the right, subject to certain exemptions, to obtain a copy of any personal data we hold about you and to correct any inaccuracies in such data. Your request will be dealt with as soon as possible and will not take more than 20 working days to process.
